When my career gave me the time and opportunity to become more involved in civic matters, I, like many Liverymen before me, stood for and was elected as a member of the Court of Common Council, in my case to the Ward of Langbourn in 2013.

**Julia**: I became involved with the Innholders in the late 1990s and spend most of my time working for a grant-giving charity for the hospitality industry. ## The Yorkshire Shepherdess takes part in the City of London Annual Sheep Drive

The Yorkshire Shepherdess, Amanda Owen, swapped the Yorkshire Dales for the day to drive sheep over the river Thames, re-enacting an ancient tradition in support of the Worshipful Company of Woolmen's Charitable Trust and Lord Mayor's Appeal.

Best-selling author of four books and star of Channel 5's "Our Yorkshire Farm", Amanda swapped her 2,000 acre hill farm in Swaledale, North Yorkshire, one of the most remote places in England, for the City of London for the day, on Sunday 26 September. Amanda accompanied the Rt Hon the Lord Mayor of London, Alderman William Russell, and hundreds of the City's Freemen, becoming river shepherds for the day as they practiced their ancient "right" to drive sheep over the Thames and into the City.

Now into its 9<sup>th</sup> year, hosted by the Worshipful Company of Woolmen, the 2021 Sheep Drive and Livery Fair took place on historic Southwark Bridge, which was traffic-free for the day. The accompanying Livery Fair included many Liveries demonstrating their skills from trades, ancient and modern, alongside a range of wool related stalls selling products that showcased the enduring relevance of wool as a sustainable and versatile material. Along with other interactive displays and food and drinks stalls, this was a wonderful family day out over the majestic Thames.

#### **Lord Mayor's Programme**

## Nairobi International Financial Centre Authority (NIFCA) Launch Event, 27 July

President Kenyatta led a Kenyan delegation to Mansion house, alongside the Foreign Secretary. The event aimed to build a deeper partnership between the UK and Kenya in financial services and green investment. The Lord Mayor and President Kenyatta signed a memorandum of understanding between TheCityUK and NIFCA.

#### Leeds and Sheffield Visit, 29-30 July

This was the Lord Mayor's first in-person regional visit since March 2020. It allowed the Lord Mayor to meet the new Mayor of West Yorkshire, Tracy Brabin, and to visit the National Infrastructure Bank on its first day in its new Leeds premises. The Lord Mayor also engaged with Leeds City Council and Leeds-based businesses including Yorkshire Building Society, Iwoca and the Open Data Institute Leeds. The visit allowed for the resumption of the annual Forfeit Feast in Sheffield with the Cutlers of Hallamshire and for the Lord Mayor to conduct his own business programme in Sheffield for the first time.

#### Indian Cricket Dinner, 7 September

The Lord Mayor hosted British and Indian businesses for a reception and dinner at Mansion House to celebrate the economic and cultural links between the UK and India. The event was timed to coincide with the England vs India cricket test match series. The then Secretary of State for International Trade, Rt Hon Liz Truss MP, attended and spoke at the event.

#### Lunch with the Lord Mayor of Westminster, 8 September

The Lord Mayor attended the annual Two Cities Lunch with the outgoing Lord Mayor of Westminster, Cllr Jonathan

Glanz. The lunch brings together civic and political stakeholders from Westminster and the City of London.

#### ASEAN (Association of Southeast Asian Nations) Virtual Visit, 8-10 September

This virtual visit built on the UK recently attaining Dialogue Partner status within ASEAN and against the backdrop of the UK Government's Indo-Pacific tilt. The visit was timely, ahead of the inaugural UK-ASEAN Economic Minister's Consultation, where financial services are a priority area of discussion.

The Lord Mayor had meetings in Singapore (discussing Digital Trade); Vietnam (meeting the Minister of Finance); Indonesia (engaging with the Finance Ministry, Sovereign Wealth Fund and regulators; and Thailand (hosting a fintech roundtable. The ASEAN Deputy Secretary General was keen to learn of opportunities for collaboration with UK financial and professional services firms.

## Innovation and Agility: the next chapter in Financial Services & The City Roundtable, 9 September

As part of follow-up to his virtual visit to Australia, the Lord Mayor met several Australian fintech firms considering entry to the UK market. He explained why Australian fintech should view the UK positively, why innovation in financial services is so important for post-pandemic recovery and explained how the City can support Australian entrants to the UK market.

#### Green Horizons Summit (GHS) @COP26 Strategic Reception, 9 September

This reception announced the full list of sponsors for GHS@COP26. They heard first-hand from UK Government representatives planning COP26 and met Mansion House and City Corporation staff who are delivering the GHS@COP26 programme.

# High Commissioners' Banquet, 13 September

The Lord Mayor welcomed attendees to Guildhall for the High Commissioners banquet. Speakers included Dr Yueh (Chair, Royal Commonwealth Society, Lord Marland (Chair, Commonwealth Enterprise and Investment Council), James Duddridge (Minister for Africa) and Baroness Vadera (Chair, Prudential).

#### China Virtual Visit, 13-17 September

The fourth of the Lord Mayor's virtual visits to China sought to promote London as the centre for global asset allocation and Environmental, Social and Governance investing. The visit consisted of smaller meetings with selected Asset Managers, as well as larger workshops with several companies. The Lord Mayor co-chaired the UK China Green Finance Taskforce, with Dr Ma Jun, for the Annual Meeting of the Green Investment Principles for Belt and Road Annual Meeting.

The visit provided an opportunity to promote the GHS@COP26 conference, highlighting Sino-UK thought leadership in sustainable finance. The Lord Mayor was joined by a strong business delegation of Asset and Wealth Managers, and by representatives from the London Stock Exchange Group.

#### Commonwealth Trade and Investment Summit (CTIS) the African Opportunity Panel, 14 September

The Lord Mayor took part in a virtual panel event during the CTIS. The discussion focused on the African Continental Free Trade Agreement and decreasing trade barriers across Africa.

#### Kuwait Joint Steering Group Roundtable, 15 September

This roundtable, held by the Lord Mayor, facilitated discussion on priority themes between the Bank of England and the Central Bank of Kuwait, highlighting themes of interest for the City of London.

#### UK-UAE Prosperity and Innovation Partnership Reception, 16 September

The Lord Mayor attended a lunchtime reception hosted by the Primie Minister at 10 Downing Street in honour of His Highness Sheikh Mohamed Bin Zayed Al Nahyan, President of the UAE. The reception celebrated the new UK-UAE Prosperity and Innovation Partnership, which enables both countries to work more closely on security, climate change and knowledge sharing.
